

Call for TILE ARTISTS and VENDORS
9th ANNUAL NORTHWEST HANDMADE TILE FESTIVAL 2014

Saturday, November 1st (10-5 PM), Sunday, November 2nd (11-3 PM)

The **HANDMADE TILE FESTIVAL** brings together tile artists, collectors, designers, architects and the general public. It consists of a **Handmade Tile Sale** and a gallery style **Juried Tile Show** open to all members of Artisan Tile Northwest.

Eligibility: ANTW members. If you are not a member, and wish to become one send a check for \$25 along with your registration for the Handmade Tile Festival. Membership forms can be found on <http://artisantilenw.org> (about us page).

Deadline for application: Postmarked by Sept. 5th, 2013 (Late fee of \$25 after Sept. 5th.) Please mail application and fees to: **Artisan Tile NW, PO Box 84872, Seattle, WA 98124.**

Table fees for Festival:

- \$125 for one full space measuring 6' x 6'. Half spaces at 3' wide and 6' deep are available for \$65.
- Spaces are available on a first come/first served basis.
- A table (30" x 72") with black tablecloth will be provided upon request. Artists must provide their own racks and display equipment.
- In an effort to keep aisles clear all items, including space for you to sit or stand, must fit in your 6' x 6' space.
- Participating artists may display garden art outside in an approximately 3' x 3' space for an additional fee of \$25. Garden art is not limited to handmade tile.
- No refund of table or registration fees for cancellation after October 10th 2014. To cancel contact Terri Goodwin at terri@bightriverstudio.com.

**Artist Agreement:**

1. This is an exhibition and sale of tiles, mosaics, tile and mosaic related objects. Objects incorporating handmade tile are allowed in the indoor space. No pots or vessels are allowed inside but are allowed in the outdoor space.
2. Tiles must be hand-made or hand-fabricated by the artist or have historic value.
3. Vendors may be asked to remove noncompliant items from their tables.

## **ATNW 2013 JURIED TILE SHOW**

**The Juried Tile Show** is a wall hung gallery show that runs concurrently with the Northwest Artisan Tile Festival. You do not need to be an exhibitor in the Festival in order to participate in the Juried Tile Show, but you must be a current ATNW member. A 20% commission goes to ATNW.

**Eligibility:** Members of ATNW. If you are not a member, and wish to become one, join by sending in a check for \$25 along with your application. One entry per person.

**Theme:** The 2013 theme for the **Juried Tile Show** is **Feathered Friends**. The piece you submit does not have to reflect the theme but only theme related pieces are eligible for cash awards. Non-themed pieces are accepted only if space is available.

**Medium:** Your piece may be made from clay, glass, stone, cement, resin or metal and must be handmade by the submitting artist. It may be a single tile, a multi-tile piece or a tile series, not to exceed 20" x 20".

**Sales:** All submissions must be offered for sale. The artist determines the price. For pieces submitted for the juried show, ATNW will take a 20% commission on each sale.

**Delivery:** Bring your piece directly to Center for Urban Horticulture on November 1st<sup>th</sup> 2013 by 8 AM. If it is necessary to make other arrangements for delivery, please contact Terri Goodwin at (206) 938-5992.

**Deadline for Juried Show entry must emailed and postmarked by:** October 8<sup>th</sup> 2014

**To enter please complete both steps below:**

- 1. Email Submission:** Please email a 72 dpi jpg digital image (at least 800 pixels per side, no larger than 1 MB) labeled with your last name and the title of your piece. These images may be used for Tile Show promotional purposes. Also include in your email: medium (clay body, firing temp, glazes), size, year created and price. This information will be used to create a label to hang with your artwork.
